Distribution boxes must comply with UL 50 (enclosures) and UL 508A (industrial control panels) standards. These standards are rigorous about short-circuit current ratings (SCCR), proper wire sizing, and component compatibility. BRCGS Global Standard Storage and Distribution Issue 4, launched in 2020, reflects best practice and facilitate a process of continual improvement through well-designed risk-based product safety management systems. It ensures the quality and safety of products during their storage and distribution. To comply with global distribution box regulations, you must meet region-specific standards including UL/NEC 1 in North America, IEC/EN standards 2 in Europe, AS/NZS 3 in Australia, and various Asian requirements. I've seen companies face heavy fines and product recalls because they copied another company's DoC without understanding their specific obligations. "How long will this take?
